Call of candidatures/for applications to take advantage of university scholarships
For the benefit ofneedy students of Moroccan community residing abroad
under the academic year 2015- 2016

I. Take advantage of the conditions relating to grants:

For students at level of License and High School:

- 1) Be authorized this annual scholarship quota limits based on social status and scientific excellence.
- 2) Made use of the grant for a period of one year subject to renewal when submit testify inscription at the top level.
- 3) Benefits from these scholarships one student for every needy family.

4 For students of Master's and doctorate wire:

- 1) Grants are authorized within the limits of an annual quota based on the social status and scientific deserve (Years of study in license and received features)
- 2) For the Master wire made use of these grants for a period of one year, renewable once, provided the transition to the second year and cannot make use of them for more than two years.
- 3) The wire doctorate can not take advantage of these grants for more than four years and be renewed annually based on the annual report prepared by the supervising professor in which he shows how student progress in the preparation of his thesis (research topic about the concerns of members of the Moroccan community residing abroad).

II. The nomination file to take advantage of these grants:

- **1.** Written request to the Minister of Higher Education and Scientific Research and Training framework under the supervision of the Ministry in charge of Moroccans living abroad and immigration.
- **2.** Fill out the form for requesting to benefit of the grant, certified by the Moroccan consular center of the territorial circle, the place of residence.
- **3.** A copy of the national identity card of the student and the consular registration card.

- **4.** Card residence of the father or legal guardian certified by the Moroccan consular center of the territorial circle, the place of residence.
- **5.** A copy of the salary certificate or a certificate attesting to the annual income of the parents and legal guardians of candidates certified by the Moroccan consular center of the territorial circle, the place of residence.
- **6.** A copy of the certificate of registration in one of the higher education public institutions according to academic year 2015-2016, certified by the competent authorities, with the translation into Arabic and French languages,
- **7.** A copy of Baccalaureate obtained in the country of residence certified by the competent authorities.
- **8.** A copy of the license certificate certified for students enrolled Master wire.
- **9.**A copy of the license and master certificates certified for students enrolled wire PhD.
- 10. School survey notes for the baccalaureate for student enrolled wire leave.
- 11. School survey notes for the students enrolled in the Master wire.
- 12. School survey notes for students enrolled wire PHD.

Filing nomination file:

Students of the Moroccan community residing abroad who are in difficult social status, who are interested in the nomination to take advantage of a grant referred to, should submit their nominate file, enhanced with documents specified above for the Moroccan consulate of the territorial circle, the place of residence.

Method of selecting candidates (How filing nomination file):

The nomination files and the selection of beneficiaries will be supported by a committee composed of the Ministry in charge of Moroccans living abroad and Migration Affairs, and the Ministry of Higher Education and Scientific Research and Training, according to the annual quota of scholarships for beneficiaries.
